## PLEASE REVIEW THIS INFORMATION CAREFULLY. Ontario's Vaccine Passport – Effective September 22, 2021

This policy comes directly from the Proof of Vaccination Guidance for Businesses and Organizations under the Reopening Ontario Act (as per section 2.1 of schedule 1 of Schedule 1 to O.Reg. 364/20:Rules for Areas at Step 3 and at the Roadmap Exit Step, under the Reopening Ontario A Flexible Response to Covid-19 Act 2020).

- Supernova Gymnastics Club will require Guest/Visitors aged 18 or older, provide proof of their full vaccination status.
- Supernova will only be accepting Medical Exemption under ROA Act. We will not be permitting entry for any other exemption reason under the ROA Act.
- Masks will remain mandatory regardless of vaccination status
- All youth 17 and under who are participating in a program at Supernova Gymnastics Club will be exempt from the passport program but will be subject to our daily screening policy upon entering the facility. Please continue to use the Ontario.ca School Screening (QR Code available on our front door).
- Safety of the children is our number one priority, and Supernova Gymnastics Club will continue to follow the guidance and mandates rolled out by the Province of Ontario, and our Durham Regional Public Health. Please be patient and kind to our staff as we learn and navigate this new addition to our screening procedure.

All patron-guests ages 18+ entering our facility (accompanying a Kindergym to view, and/or participating in a Parent & Tot "Holding Hands class), or athletes over age 18, will be required to provide proof of their vaccine receipt showing they are fully vaccinated with a piece of Government issued ID.

- If patron-guests 18+ do not wish to disclose their status or state they are not vaccinated, they will
  not be permitted entry to Supernova Gymnastics Club.. For those registered Kindergym (ages 3-5)
  the parent may notify us that Cartwheels is to be a 'caregiver' for their Kindergym participant and
  not enter our viewing area themselves. Programs for our NovaGym Recreational Boys and Girls
  (ages 6+) will continue to be drop-off/no viewing so this policy does not currently affect your
  registration.
- If the patron-guest over 18 years, chooses not to disclose and is not open to assigning someone to be a caregiver (for Kindergym)

  — they will not be permitted entry. In this instance, pro-rated refunds will be issued for Supernova Gymnastics Club programming. Refund requests will be prorated to refund classes not yet taken. We do not collect or record your status ahead of time. We will require it to be shown for entry as of Wednesday September 22, 2021.

## WHO WILL NOT NEED TO SHOW PROOF OF COVID-19

Patrons under 18 years of age who are entering the indoor premises of Supernova Gymnastics Club, solely for the purpose of participating in our program, will not need to show proof of vaccination.

Patrons who are entering for drop off and pick up only, office inquiries, and those who will not be spectating or be in the facility for a length of time longer than 10 minutes are also exempt from the proof of vaccination requirement.

Patrons who provide a written document, completed, and supplied by a physician "MD" or by a registered nurse stating that the individual is exempt for a medical reason from being fully vaccinated against Covid-19, and the effective time-period, for the medical reason. Please see Ministry of Ontario guidelines for what needs to be on said document. WHO WILL NEED TO SHOW PROOF OF COVID-19 VACCINE

Patrons over the age of 18 that are visiting, spectating, or participating at Supernova Gymnastics Club (this includes classes in which a parent/guardian assists a child), must provide the receipt that shows that they are fully vaccinated. Proof of vaccination will be accepted if the person's name and date of birth on their identification document matches the vaccination receipt, with name and date of birth and if the person is fully vaccinated. Under the ROA Act, "full vaccination" is 14 days post second dosage.

## WHAT DO YOU NEED TO BRING

- Vaccination receipt showing two doses (print out or screen shot on your phone).
- One of the following- Birth Certificate, Health Card, Drivers License, Status Card, Permanent Resident Card.

Supernova Gymnastics Club will not retain any information provided by a patron, if the information is provided pursuant to a requirement under section 2.1 of schedule 1 of O.Reg.364/20 under the ROA.

Due to this new regulation, Supernova encourages our patrons to follow consistency with which parent/guardian enter our facility to provide ease and continuity with the screening
